


# Display of Pyrotechnics Application Information

For Tooele County's fire protection jurisdiction <u>only</u> (area in green below). For another jurisdiction, contact that respective agency.



In order to set off any sort of pyrotechnics in Tooele County you will need to acquire a permit from the authority having jurisdiction. While setting off fireworks for the 4<sup>th</sup> of July or another celebration is an enjoyable way to spend an evening, pyrotechnics do pose certain fire risks. We'll gather information on the type of pyrotechnics your will be setting off, when and where you'll be setting them off, and will work with you to ensure you have a legal and safe celebration.

### **Pyrotechnics Permit Steps:**

**Step 1** – Submit application and pay fees:

Please fill out form below and pay fees. Fees must be paid before your plan review can begin.

Step 2 - Submit Plans:

**Step 3** – Plan review and project clearance letter:

After steps 1 and 2 are completed, the Tooele County Fire Department will conduct a plan review and issue a project clearance letter.

**Step 4** – On site inspection day of event. Must schedule inspection 48 hours in advance.

Standby fees: standby by a Fire Department may be a condition of permit approval. Additional fees will apply.

# Display of Pyrotechnics Application

# Fee \$40 per man-hour expended

Tooele County Fire Department requires that a permit be issued to maintain, store, use or handle materials, or to conduct processes which produce conditions hazardous to life or property, or to install equipment used in connection with such activities. Such permission shall not be construed as authority to violate, cancel or set aside any of the provisions of the code. This permit shall not take the place of any license required by law.

\*\*Evidence of financial responsibility by the sponsor of the event or festival and by the operator of the fireworks display. Provide proof of public liability and property damage insurance for at least \$1 million dollars. \*\*

# **Site Diagram**
