<p>Seasonal Restrictions on BLM Lands</p>	<p>June 15 - Sep. 30</p> <p>Use of any steel core, jacketed, and tipped ammunition of any caliber.</p>	<p>Active from June 15 until Rescinded</p> <ol style="list-style-type: none"> 1. Use of any tracer or incendiary ammunition of any caliber. 2. Possession or use of any kind of explosives, incendiary or chemical devices, pyrotechnics or fireworks, or exploding targets. 3. Use of sky lanterns, Chinese lanterns, fire balloons, acetylene balloons, or similar device. 4. Use of any off road vehicle that is not equipped with a properly installed and maintained spark arrestor. Spark arrestors shall meet the 80 percent efficiency level standard when determined by the appropriate SAE recommended practices J335 and J350. Refer to Title 43 CFR 8343.1
<p>Additional Potential BLM Restrictions When extreme conditions exist</p>	<p>Fire restriction information and official documentation can be found at: https://utahfireinfo.gov</p> <ol style="list-style-type: none"> 1. Campfires, except in permanently constructed cement or metal fire pits provided in developed campgrounds and picnic areas. 2. Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area that is paved, barren, or cleared to mineral soil. 3. Cutting, welding, or grinding metal in areas of dry vegetation. 	
<p>BLM Exemptions</p>	<ol style="list-style-type: none"> 1. Any federal, state, or local officer or member of an organized rescue or firefighting force in the performance of an official duty. 2. Persons with a BLM-issued permit specifically authorizing an otherwise prohibited act. 3. The general public using "Class C common state approved" fireworks on July 4 along the access road to the Bonneville Salt Flats Special Recreation Management Area. "Class C common state approved" fireworks are fireworks that are purchased at a retail store in the State of Utah for use by a consumer in Utah. 	
<p>State and Unincorporated Private Lands Potential Fire Restrictions when extreme conditions exist</p>	<ol style="list-style-type: none"> 1. Setting, building, maintaining, attending or using open fires of any kind, except within the facilities designated for them in improved campgrounds, picnic areas or home sites where running water is present. 2. Smoking, except within an enclosed vehicle, trailer or building, a developed recreation site or while stopped in an area that is paved or free from dry vegetation. 3. Discharging or using any kind of fireworks, tracer ammunition or other pyrotechnic devices including exploding targets. 4. Cutting, welding or grinding metal in areas of dry vegetation. 4. Operating a motorcycle, chainsaw, ATV, or other similar small internal combustion engine without an approved and working spark arrestor. 	
<p>State and Private Exemptions</p>	<ol style="list-style-type: none"> 1. Persons with a permit or waiver specifically authorizing a specified act at a specified location. 2. Any on-duty firefighter in the performance of an official duty.
